**OCSE Federal Case Registry (FCR) and Related Systems**

The Federal Office of Child Support Enforcement (OCSE), Federal Parent Locator Service, supports various programs and initiatives that support the location of participants in child support cases, collection of child support payments, enforcement of child support orders, communication between States, and online profile information regarding how counties, States, regions, Tribes and international offices operate. The Federal Case Registry (FCR) contains state Child Support Enforcement (IV-D) and non IV-D case data and serves as a pointer system to help locate persons across state lines. Title IV-D refers to state-run child support enforcement programs which are funded through grants provided for by the Social Security Act of 1975. Title IV of the Social Security Act covers grants to states for the purpose of providing aid and services to needy families with children and for child-welfare services. Part D of that law covers child support and the establishment of paternity.

Person-specific data in the FCR are matched daily against employment data in the National Directory of New Hires (NDNH) and sent to states to facilitate case processing and increase collections, especially through automated income withholding. Additionally, matches are sent to states to inform them if a IV-D case participant in their state appears as a participant in a IV-D or non IV-D case in another state. The FCR also serves as the conduit for matching against the following sources: Department of Defense (DOD), Department of Veteran Affairs (VA), Federal Bureau of Investigation (FBI), Internal Revenue Service (IRS), National Security Agency (NSA) and Social Security Administration (SSA). In September 2002, the Federal Office of Child Support Enforcement (OCSE) conducted a study to gauge state interest in an Interstate Case Reconciliation (ICR) project to be performed at the national level. Based on the interest level among the states, in May 2003 OCSE decided to proceed with the project. Participating states write and transmit to OCSE an extract file of all cases they consider interstate. OCSE matches the extracts with all participating states' extracts (or with FCR-derived data for non-participating states), and returns the matched cases (broken down by error reason codes) for state reconciliation.

~~**National Directory of New Hires (NDNH)**—NDNH provides new hire, quarterly wage and unemployment information. The purpose of the National Directory of New Hires (NDNH) system is to provide a national directory of employment and unemployment insurance information that will enable state Child Support Enforcement (IV-D) agencies to be more effective in locating noncustodial parents, establishing child support orders and enforcing child support orders. State Directories of New Hires (SDNHs), State Workforce Agencies (SWAs), and Federal agencies provide information to the NDNH-~~

~~**Defense Eligibility Enrollment System (DEERS)**—DEERS system provides information to FCR about children eligible for TRICARE medical coverage-~~

~~**Interstate Case Reconciliation (ICR)**—data is received from the States, ACF matches the data, and then returns the data to the States for data reconciliation—provides case and participant information about interstate cases for reconciliation with other state interstate cases-~~

**Disposition: TEMPORARY.** Cut off at the end of the fiscal year in which case is closed Delete three years after cutoff

(b) **Locate, Locate Source and NDNH Match Result records**

Data elements include the following.

Locate Data – Name, SSN, Date of Birth, Sex, State, User Code, SSN Verification, Request Type, State Case Id, Participant Type, Requestor Id

Locate Source Data – SSN, Locate Source, Locate Date, Results Code, Locate Sent Date

NDNH Match Result Data– State, Participant Type, NDNH Type, SSN Searched, SSN Not Matched

**Disposition: TEMPORARY.** Cut off at the end of the fiscal year in which request is completed Delete three years after cutoff

(c) **Locate Response records** Information collected from matches with systems at other Federal agencies These records include location, income and asset data Data elements depend on the source of the information and include the following

DOD Name, SSN, Date of Birth, Agency Code, Pay Grade/Rank, Annual Salary, Date of Hire, Employment Status, Termination Date, Reporting Agency, FEIN

FBI Name, SSN, Annual Salary, Date of Hire, Employment Status, Termination Date, Death Date

NSA Name, SSN, Annual Salary, Date of Hire, Employment Status, Termination Date, Death Date, FEIN

DVA Name, SSN, Date of Birth, Benefit Indicator, Date of Death, VA Effective Date, Amount Award, Retirement Indicator, Active Reserve

**Disposition: TEMPORARY.** Cut off at the end of the fiscal year in which received Delete three years after cutoff

(d) **Locate Response records containing Federal Tax Information (FTI)** Information

Delete five years after cutoff

**(e) NDNH Response records**

Data elements from NDNH Responses include the following

New Hire Data Employee Name, SSN, Address, Employer Name, Federal Employer Identification Number (FEIN), Employer Address

Quarterly Wage Data Employee Name, SSN, Quarterly Wage Amount, Employer Name, FEIN, Employer Address

Unemployment Insurance Data SSN, Address, Reporting State, Quarterly Benefit Amount, Reporting Quarter

Data elements from ICR include interstate case information including Case Number, SSN, Member ID, Participant Type, Name, Date of Birth, Sex, Contact Name, Phone, email

**Disposition: TEMPORARY.** Cut off at the end of the fiscal year in which received  
Delete one year after cutoff

**(f) ICR records**

Data elements from ICR include interstate case information including Case Number, SSN, Member ID, Participant Type, Name, Date of Birth, Sex, Contact Name, Phone, email.

**Disposition: TEMPORARY.** Cut off at the end of the fiscal year in which received  
Delete three years after cutoff

**(g) Records relating to fraud or abuse investigations or legal actions** Any record relating or potentially relating to a fraud or abuse investigation or a pending or ongoing legal action including a class action, is retained until conclusion of the investigation or legal action

**Disposition: TEMPORARY.** Cut off at end of fiscal year in which created or received  
Delete 3 years after cutoff or upon conclusion of the related investigation or legal action, whichever is later

**Item 3. Output Records**

**(a) Acknowledgements and Match Results for States:**

This includes system generated acknowledgement records to State Case Registry (SCR) submitters of FCR data, notifications sent to SCR of child eligibility in DEERS TRICARE, match results generated as a result of data comparisons including but not limited to matches of FCR and NDNH data, Multi-State Financial Institution Data Match (MSFIDM) account match information and insurance match claim information, responses sent to SCRs containing location, income and asset data resulted from a successful match with external Federal agencies (Agencies are listed in the system description section of this document) and match results generated as a result of FCR or ICR comparisons which locate individuals who are participants in child support cases or orders in more than one state These reports are transmitted to the relevant States for their information

**Disposition: TEMPORARY.** Cut off every 60 days Delete after cutoff

**(b) Federal Agency Locate Requests:** This includes requests sent to the federal agencies asking them to provide information about the location and income of an individual It also includes requests to the Department of Defense for eligibility of children for TRICARE medical coverage

**Disposition: TEMPORARY.** Cut off every 60 days Delete after cutoff

**(c) Data Extracts for the IRS** Copies of the FCR records transmitted annually to the IRS for the purpose of administering the earned income tax credit program

**Disposition: TEMPORARY.** Cut off at end of the fiscal year Delete one year after cutoff

**Item 4. System Documentation**
