<i>1</i>	SEE ATTACHED SHEET(S) Customs Declaration (CF 6059B): All persons entering the United States are required to declare to the BCBP Officer at the port of first arrival in the U.S. The BCBP Baggage Declaration is used as a standard method to determine the identity, nationality, and residence of all persons arriving in the U.S. by airplane and ship. The declaration facilitates BCBP enforcement of various prohibited and restricted importation laws relating to agricultural products, endangered sources and the currency reporting laws. It also allows BCBP to be selective in the inspection process. Disposition: A) Free declarations Retain for three years and destroy. B) Dutiable declarations Retain for six years and destroy This change is made as a result of a series of historical events and use.
