### Fire Reporting System

**Description of System.** The Fire Reporting module provides access to the interagency fire occurrence reporting system for the Bureau of Indian Affairs (BIA), Bureau of Land Management (BLM), and National Park Service (NPS). This system collects, and stores data from wild land fires managed by the BIA and NPS. Records are dated BIA and NPS 1901 – Present, BLM 1970 – Present and BOR 2005 - Present

**a. Master File.** The database contains fire reports for BIA, BLM, NPS, and BOR, entered by agency personnel

#### *DISPOSITION PERMANENT*

TRANSFER, A COPY EVERY 10 YEARS TO THE NATIONAL ARCHIVES WITH A PUBLIC USE VERSION, IN ACCORDANCE WITH 36 CFR 1228.270 (I.E., RECORDS DATED 2004 TO 2014 ARE TRANSFERRED IN 2015, RECORDS DATED 2014 TO 2024 ARE TRANSFERRED IN 2025, AND SO ON)

**b Back-up copies.** Backup copies of the master file are created daily, weekly and monthly and are used for potential system restoration in the event of a system failure or other unintentional loss of data

#### *DISPOSITION TEMPORARY DESTROY*

Delete/destroy full backup tapes when second subsequent backup is verified as successful or when no longer needed for system restoration, whichever is later (GRS 20, Item 8)

**c. Input Records (paper).** Form DI-2012, Fire Reports

Cutoff EOY. Transfer to FRC 10 years after cutoff. FRC offers to NARA in 10 year blocks when most recent records are 10 years old (GRS/BLM 18/32)
