110-18	<p><u>MANUSCRIPT VOLUMES OF LEGAL DECISIONS</u></p> <p>Commonly referred to as manuscript volumes, these records consist of copies of the legal decisions of the Comptroller General concerning procurement law, civilian and military personnel law, appropriations, and general legal issues raised by GAO's audit staff. External decisions are rendered to heads of Federal agencies and to disbursing and certifying officers within the government. The decisions along with related indexes are maintained by the Index-Digest Section of the Legal Information and Reference Services Branch of the Office of the General Counsel. A variety of the more recent decisions are restricted to use within GAO. These include decisions sent to requestors who are not entitled to a formal determination by the Comptroller General (as defined by law) and internal memoranda sent to GAO officials. Background documentation for each decision is found in the A and B Files described in Item 110-02 of the comprehensive records control schedule. Each decision has an A or B File number which corresponds to its background folder. These numbers are assigned chronologically and without regard to the subject of the decision.
