| 1 | <p>This request is designed to ensure that records created by the Bureau of Reclamation, Department of the Interior, are not exempt from the provisions of the following previously approved schedules:</p> <p>a. <u>National Archives Job No. NN-171-4</u></p> <p>The exclusion of "...all accounts and supporting documents of the Bureau of Reclamation, U.S. Department of the Interior...." is eliminated.</p> <p>Those records are now to be disposable 10 years and 3 months after the period of the account.</p> <p>b. <u>National Archives Job No. NN-164-145</u></p> <p>This job was informally amended to exclude Bureau of Reclamation contracts.
